



# ST AIDAN'S CHURCH OF ENGLAND HIGH SCHOOL 16–19 BURSARY FUND POLICY

Academic Year September 2025 to July 2026

All students may apply for a bursary (non-discretionary and discretionary). Bursaries are intended for students who are in most need of financial student support and the eligibility criteria reflects this intention.

Both types of bursary funding are designed to help students overcome the individual financial barriers to participation they face, and we must ensure the funds go to those who genuinely need them. No student will be automatically awarded a set amount of funding without an assessment of their level of actual financial need.

The funds are intended to assist with expenditure that is directly related to school life including transport, study resources, an allowance on your St. Aidan's catering card, course-related trips, UCAS administration fee and university open days.

The bursary fund is not intended to support costs unrelated to education (living costs), extracurricular activities or provide learning support, such as counselling, mentoring or extra tutoring.

Bursary fund payments must not be made for living costs. This is out of scope of the bursary fund and any such payments would be subject to the Social Security Amendment (Students and Incomerelated Benefits) Regulations 2000.

Our Bursary Policy is informed by the Department of Education's (DfE's) <u>16-19 Bursary Fund guide</u> <u>for 2025 to 2026</u>

#### The 16-19 Bursary Fund will be targeted at two qualifying groups:

- 1. Students that are in care; care leavers; in receipt of Income Support or Universal Credit in place of income support, **in their own right**; in receipt of Employment & Support Allowance or Universal Credit & Disability Living or Personal Independence Payments **in their own right**. These students may receive a bursary of up to £1,200 a year.
- 2. Students with an adult household income of up to £25,000.

The value of the bursary awards to group 2 will depend on the number of students that apply and figures will not be known until mid-October.

## Eligibility

To be eligible to receive a 16-19 Bursary in this academic year, the student must be aged 16 or over and under 19 on 31 August 2025. Those aged 19 or over are only eligible if continuing a study programme started before the age of 19 or have an Education, Health and Care Plan (EHCP).

For a student to be eligible for funding, the student must have the legal right to be resident in the United Kingdom at the start of their study programme.

Students will be required to produce their passport, or other qualifying document, as proof of eligibility. Further guidance on residential eligibility can be found in the 2025/2026 DfE Funding Guidance

#### **Bursary Fund groups**

#### **Group One (non-discretionary)**

To be eligible for the Level One bursary of up to £1,200, students must be in **one** of the defined groups:

- in care
- a care leaver
- in receipt of Income Support (IS) or Universal Credit (UC) in place of Income Support, in their own name
- be in receipt of Disability Living Allowance (DLA) or Personal Independence Payments (PIP)
  and Employment and Support Allowance (ESA) or UC in their own name.

## **Group Two (discretionary)**

Students with an adult household income of up to £28,000 which should be evidenced accordingly for new applications.

#### Who should apply?

All Year 12 students, who meet the eligibility criteria, should apply and provide the supporting documentation.

All Year 13 students, who meet the eligibility criteria, and have not previously received a bursary, should apply and provide the supporting documentation.

Year 13 students, who received a bursary in 2024-2025, and whose household circumstances have not changed, should apply. Parents/carers will not need to provide supporting documentation but must, along with the student, complete the self-declaration form.

#### Approval of your application and payments.

You will be advised by email if your application is successful.

Claims must be submitted using the 16-19 Bursary Claim form, available from the bursary section of the school's website.

The DfE advise that financial support should be either in-kind (e.g. buying bus passes, books or topping up catering accounts). Payments in-kind can only be made where the value of the purchase is below that of the funds being allocated.

Where in-kind payments are not practical, cash payments may be given ahead of a purchase being made.

Where payment is in cash, receipts **must** be retained and provided as evidence to support the payment being made. This is an essential part of our audit sampling and assurance process.

Payments (either in kind or cash) will be made regularly as determined by each student's individual needs.

This year's (2025/2026) final claim forms should be submitted no later than Friday 3 July 2026.

#### **Educational Trips and catering**

Where an application for assistance towards the cost of a school trip or catering is approved, the allocated amount will be credited to the student's Arbor account. Any remaining balance due will be shown on Arbor and is payable by the student.

Reimbursement will be made clothes for Sixth Form, shoes and school bags which adhere to the dress code of the Associated Sixth Form.

The deadline for purchases is:

Year 12 students	If not returning to Year 13 – 3 April 2026
Year 13 students	3 April 2026

#### Attendance and Behaviour Requirements.

Claims will only be paid to eligible students who adhere to the following criteria.

To receive the Bursary, students should have no unauthorised absences. It is our expectation that students will attend registration periods, Core Learning and all timetabled lessons. Please note holidays will not be authorised absences. Approved Examination Study Leave, participation on approved educational trips, or approved representative activities will be counted as attendance.

If students are unacceptably late to lessons or registration, then these will count as an absence and therefore no reimbursement will be made for that half term.

Students must abide by the standards of behaviour and effort as agreed at the start of their learning programme as detailed in the Sixth Form Student Handbook. If poor behaviour or effort is reported and supported by documentary evidence, the student will not be paid for that half term

# Applications and closing date

Students who believe that they may be eligible to apply should complete the 16-19 Bursary 2025/2026 application form available from the Sixth Form office or the <u>Bursary section</u> of the St. Aidan's website.

All completed applications, which should include proof of income detailed on the form, must be received no later than 5pm Monday 29 September 2025.
